VII. NEW BUSINESS

- a. January 2014 Newsletter Draft presentation for board member comment
 - Rick Koon reviewed the articles for the January 2014 newsletter. Included will be a map that shows where force main breaks and repairs have been completed since 2012 as well as the areas which are scheduled for replacement in 2014. John Delehant will update the president's message which will include an invitation to attend an open house on February 21. SMMWC's rate changes, our new address and our auto-debit program will also be in the newsletter.
- b. Stage I Water Conservation Consideration of Implementation
 - Motion made by Tom Athey, seconded by John Delehant to implement Stage I: Voluntary Conservation Minor (10% voluntary water use reduction) of Resolution No. 2009-001, SMMWC Water Conservation Policy. Motion passed 6-0. Notice of reduction request will be printed on the January 2014 bills.

VIII. GENERAL MANAGER'S REPORT

- Administration
 - The final punch list items for the new building have been completed. A fire alarm panel, Knox Box and address numbers have been installed as required by Cal-Fire.
 - Per the Post Office, our physical address is 1561 Sparrow Street, San Luis Obispo, CA 93405-8056. Our mailing address will remain the same.
 - We received a refund of \$1,586 from State Fund Insurance.
- Operations
 - All water being delivered is from our wells with no State water being delivered.
 - We are testing the THM levels within the system to determine if there is a correlation between our water source deliveries and the THM levels.
 - The lift stations and water booster stations are functioning normally.
 - We are dewatering pond 1 into pond 2 at the treatment plant in preparation for sludge pumping.
 - There are new reporting requirements for all wastewater discharge permits. Our legal team has provided us with a summary of the revisions we need to implement.
- Capital Project
 - The LS #2 to LS #3 pipeline replacement project is progressing well.
 - A meeting was held with Dylan Wade of WSC to outline the elements of a reserve study. WSC will provide us a cost estimate by the end of January.
