#### V. REVIEW and APPROVAL OF MINUTES

- a. Review of 2013 Financial Statements
  - Motion made by John Delehant, seconded by Tom Athey to approve the 2013 Financial Statements as reviewed. Motion passed 6-0.

### VIII. GENERAL MANAGER'S REPORT

- Administration
  - Water Conservation Using the 2 year average data and a 10% use reduction, we estimated our revenue based on the current tier structure. Compared to a direct 10% budget reduction using Financial Officer Athey's revenue model, both numbers were within \$300.00 of each other.
  - State Water delivery for 2014 has been raised by the DWR to 5% of requested.
  - Our website us up and running.
- Operations
  - On May 6, 2014 there was a fire near San Luis Bay Inn which caused a power outage. All of our generators came on and ran for a little over an hour except for the generator at Lift Station #2. Lift Station #2 was on generator power for about 14 hours.
  - We need to replace the control screen at the Kingfisher booster station. The control screen did not return to normal after the outage. We are working with the telemetry contractor and supplier to receive a warranty replacement unit.

- There was a cracked pipe fitting and deteriorated metal coupling in the influent line at the wastewater plant. We lowered the water level of the entire plant to make repairs. The \$6,700.00 repair cost will be an unscheduled expense item.
- Staff continues to clear root intrusions from manholes.
- Capital Projects
  - We have purchased two new trucks. SMMWC received over \$4,500.00 in rebates.
