II. PUBLIC/SHAREHOLDER COMMENT – Bob Pusanik wanted to make sure that we were going to be address the Regional Water Quality Control Board letter that was in our meeting packet.

III. REVIEW and APPROVAL OF MINUTES –

- a. July 16,2021 Regular Meeting Minutes Motion to approve the minutes with edits made by Paul O'Malley seconded by Robert Peterson. Motion passed 6/1, St Pierre abstained.
- IV. WATER SYSTEM CONSULTING UPDATE TO THE 2015 WATER RESOURCES STUDY Dylan Wade from WSD used an overhead presentation to summarize and illustrate the constituents in our well water, state water, our typical blended water and how the constituents compare to the water quality in Pismo Beach, Grover Beach and Arroyo Grande. Dylan requested the Board of Directors to provide guidance regarding the water quality goals/levels they would like us to target for the proposed well head treatment system in anticipation of the Company using less State Water to improve the overall quality of the water. Dylan also discussed the potential impacts the well water treatment could have on the wastewater treatment system and the potential for new, more stringent, wastewater discharge requirements. The Board deliberated and discussed the target well water quality objectives and provided guidance that staff should target a TDS water quality range of approximately 250 400 mg/L.

Dylan introduced the California Drought Relief Program that is offering grant money to assist with upgrading water systems within the State of California. Dylan recommended the Board consider applying for a grant that would assist with planning and construction of the well water treatment system. The Board of Directors requested Dylan to prepare a proposal for preparation of the grant application and scheduled a special meeting for Friday August 27th to consider moving forward with the grant application.
