- Administration

- Operations
  - Staff replaced several leaking angle stops in Pelican Point and Indian Hill.
  - Dechance Construction replaced frames and covers on seven manholes. They also regrouted the grade rings on the manholes.
  - Heron Crest HOA repaired a sinkhole on Playa Vista in front of the water booster station. The HOA believes there is a leak around our sewer at the next upstream manhole. At our request, Dechance Construction inspected the manhole and determined there is no leakage. General Manager Koon will inform Heron Crest HOA of their findings.
- Capital Projects
  - We are still testing the SCADA system.
- Additional Projects
  - SMS Sewer Service Contract This item will be reviewed in the BOD's closed session.
  - ABCSD Regional Study WSC scope of work has been approved and they have started the project.
