I. CALL TO ORDER AND ROLL CALL

Meeting called to order by Board President John Delehant at 9:06 a.m.

II. PUBLIC/SHAREHOLDER COMMENT – Mr. Vorie talked about a creek disturbance by Sycamore, he noticed some septic tanks being put in. General Manager Rick Koon informed him that we have no knowledge of that project and that he has not seen any permit requests. General Manager Koon also stated that it may be tanks for a grey water system.

- Heron Crest Booster Station – The work on updating the VFDs has shown a drop in PG&E costs.

- Kingfisher Booster Station – The new VFDs have lowered our PG&E costs.

- Staff is looking into installing a solar powered chlorinator at tank 400 similar to the one installed at 100 & 200.

-Wastewater

- The WWTP continues to operate efficiently.

- All lift stations are functioning normally.

- Capital Projects

- Lift Station #3, pump #2 has been reinstalled and is functioning well.




