- Administration
 - Created Ballot Check-in List as requested by Election Inspector
 - Prepared May Regular Meeting and Annual Meeting Packets
- Operations
 - Installed the new wastewater pump at Lift Station 3 and returned the standby rental pump
 - Diagnosed, and eventually removed and replaced the pump at Well 5A
- Capital Projects
 - Tank 550 Project Contractor completed major work on Tanks 550 including, cleaning, sand blasting, structural repairs and recoating. Project is scheduled to be completed by the end of May.
- Additional Projects
 - Staff at the Central Coast Regional Water Quality Control Board contacted the company and advised that they intend to update the Company's sewage treatment plant Waste Discharge Requirements (Permit). The existing Permit was issued in July 1995. Instead of issuing a new individual Permit, the Water Board is now regulating treatment plants with Statewide or Regional "General Order" depending on the capacity of the plant. Hagemann met with Water Board staff on May 7th (via zoom) and I will accompany Water Board staff on a WWTP inspection on Thursday May 20th.
