The county has changed their treatment Operation per the SWRCB recommendation after their boil notice resulting in a concern of higher them normal cooper results from disinfection process SMMWC as a result has been instructed by SWRCB to retest for Cooper/Lead in September of this year Maintenance

- Telemetry work was completed to finish some ongoing issues with readings on our SCADA system, and some reprogramming was completed is fix the issues.
- Tanks have been raised to 23-20ft to help with demand issues and fire season.
- Operational staff has replaced (number) 30 new blue dots to indicate Hydrant location for nighttime per code this will continue for the next month to finish up all areas.

Wastewater Maintenance

- Wet Well #1 was giving bad readings and turning pumps on and off. Low float was replaced in wet Well #1
 to address the issue.
- Lift station# 3 bearing going out in motor #1, Operation staff pulled the motor with our Staff and equipment. The motor was sent down to Perry's electric for bearing replacement and was back operational in 2 days. In the past we would contract for the removal, and it would take much longer to repair.
- New conduits had to be installed to get the new aerators operational, roots and dirt compacted in them leaving
 operational staff no choice but to replace all conduits and new junction boxes, all this work was performed by
 SMMWC operator to cut costs to the project. Alpha Electric will install the new electrical wire and breaker

- We continue to move forward with new meter replacements every month and are on task to finish in October.
- 15 new manhole rings and collars have been completed in Indian Hill and on Lupine Canyon Rd.
- 3 new outbuildings tuff sheds for all electronic equipment at all tank sites have been completed. All telemetry components completed.
- New wire is being pulled for the new aerators for WWTP by Alpha Electric Company
