III. REVIEW and APPROVAL OF MINUTES –

- a. July 19, 2022 Regular Meeting Minutes Motion to approve the minutes made by Marvin St Pierre, seconded by Larry Bitner. Motion passed 7/0.
- IV. DISCUSSION ON THE MARRE WEIR 65% DESIGN Dylan Wade from Water Systems Consulting used a slide show presentation to update all those in attendance of the project. The Board of Directors has formed a subcommittee of Michael Nordstrom, Rob Rossi, Marvin St Pierre and Rick Koon to counsel and oversee San Miguelito's interest in the multi-agency project.
- V. DISCUSSION AND CONSIDERATION OF A POTENTIAL SALE OF A PORTION OF THE COMPANY'S STATE WATER TABLE A ALLOCATION—Presentation given by Geoff English, the General Manager, went over the reliability of the Company's three wells, potential cost savings in reducing the Company's allotment of State Water and the quality of the water with a high percentage of well water. Recommendation by the General Manager to Authorize him to meet with the County of San Luis Obispo to discuss the proposed sale of 125-acre feet of the company's 275-acre feet of Table A State Water and to coordinate and initiate a process to secure a potential buyer. Motion to approve as recommended made by Larry Bittner, seconded by Paul O'Malley. Motion passed 7/0.
- VI. DISCUSSION ON THE WATER QUALITY QUESTIONNAIRE RESULTS The water survey was distributed to 678 customers, 65 were completed and returned to our office. GM, Geoff English went over the results of for each question. Overall, 83.1% of the customers served rated SMMWC water acceptable.
- VII. DISCUSSION AND CONSIDERATION OF AGREEMENT WITH CREEKLANDS The General Manager requested authorization to execute a Consultant Services Agreement with Creek Land Conservation in the amount of \$34,540.00 for permit completion, grant preparation and project coordination to bring the Marre Weir Project to 100% completion. Motion to approve made by Marvin St Pierre seconded by Paul O'Malley. Motion passed 7/0.
